Receiving Water And Location: An unnamed tributary to the Yellow River in the Yellow River Watershed in the Lower Chippewa River Drainage Basin in Barron County
Brief Facility Description and Summary of Proposed Changes: Lakeland Sanitary District #1 owns and operates a domestic wastewater treatment system. The plant designed to treat 34,000 gallons per day, currently treats an average of 7,000 gallons per day (2019-2023 data). The facility consists of three stabilization lagoons operated one after another (in series). Within these ponds naturally occurring bacteria and organisms already present in the wastewater metabolize organic matter. The cleaned wastewater (effluent) is authorized to be discharged to an unnamed tributary to the Yellow River during the months of April, May, September, and October.

It is the Department's intention to renew the permit for another term. The proposed new permit expiration date will be June 30, 2029. Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Significant changes from the previous permit include: [1] Effluent BOD5 and Total Suspended Solids (TSS) limits based on Limited Forage Fish standards replace variance limits as described in s. NR 104.02(4)(c), Wis. Adm. Code. A schedule has been included to provide time to meet the TSS limit. [2] An effluent variable daily maximum for ammonia has been added to the permit. [3] Annual effluent Total Nitrogen (TKN, NO2+NO3 and Total N) monitoring in rotating discharge seasons has been added to the permit [4] The Department has determined that the permittee is eligible for a phosphorus multi-discharger variance (MDV) in accordance with s. 283.16, Wis. Stats. The MDV provides a time extension for the permittee to comply with the final water quality based effluent limits for phosphorus while contributing funds towards nonpoint pollution control projects to reduce phosphorus. Comments on this determination are requested and additional supporting documentation and data are available upon request.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.
